Informamos que, de acordo com a Portaria SECEX nº 21, de 30 de março de 2020, O Departamento de Defesa Comercial (DECOM) transmitirá eletronicamente suas notificações e comunicações às partes interessadas dos processos de defesa comercial, por meio de correio eletrônico.
