- 1- All registration procedures are available on the web site of the General organization for Export and Import control <u>www.goglc.gov.ec</u>
- 2. The required documents have to be translated to Arabic Language.
- 3- Accredited Translation offices are determined by Turkish Institutions (Notary, chamber of commerce).
- 4- The exporting companies are required to upload all related documents to the official website for the General organization for export and import control <u>www.zoelc.sov.eg</u> offor review and any approval.
- 5- In case of approval, the applicant company will be potified by GOEIC, after words the company has to submit the originals to the Egyptian Embassy or General consulate for legalization and authentication.
- 6- The company is required to submit all the original legalized documents to any of the affiliated registration offices of GOEIC in Egypt and fill out registration form .
