INVESTIGATION INTO THE ALLEGED DUMPING OF PASTA ORIGINATING IN OR IMPORTED FROM EGYPT, LATVIA, LITHUANIA AND TURKEY

The Government of the Turkey is hereby informed that the Commission has decided to initiate an investigation into the alleged dumping of Pasta originating in or imported from Egypt, Latvia, Lithuania and Turkey.

Enclosed is the copy of the public notice in this regard which was published in the Government Gazette on 18 September 2020, together with a copy of the non-confidential application and the foreign manufacturers/exporter questionnaire that is required to be completed by all manufactures/exporters.

The Commission is currently in the process of contacting all known manufacturers and exporters of the subject product to the SACU in order for them to be given an opportunity to co-operate with the Commission and to



assist in the investigation. Should you be aware of any manufacturers or exporters from your country, you are requested to forthwith transmit the documents to such manufacturers or exporters and to inform the Commission immediately thereof.

It should be noted that the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR) provides that the time-limit for exporters shall be counted from the date of receipt of the questionnaire, which for this purpose shall be deemed to have been received one week from the date on which it was sent to such exporter or transmitted to the appropriate diplomatic representative of the exporting country, that is 21 September 2020. The date of receipt shall in this case be deemed to be 27 September 2020.

All responses or any information regarding this matter and any arguments concerning the allegations of dumping and material injury must therefore be submitted in writing and must reach the Senior Manager: Trade Remedies I, International Trade Administration of South Africa (ITAC), Block E – the DTI Campus, 77 Meintjies Street, Sunnyside Pretoria, South Africa, 0001, not later than 15:00 on 27 October 2020.

If you require any clarification or further information pertaining to anything in the application or regarding the investigation, you should request the information at an early stage, well before the period for comments has lapsed, in order to ensure that you receive the additional information and still have time to comment thereon within the time frame referred to above.

All adjustments that are required by respondents must be disclosed in the response to the questionnaire with all calculations and supporting documents to the adjustments claimed. The Commission will not consider any new adjustment claims on verification and unsubstantiated claims will be taken as incomplete adjustment submissions and will not be considered.

Please take note that the rules relating to confidential information and the

submission of non-confidential versions of submissions in the public notice

applies to ALL correspondence, which unless clearly indicated to be

confidential and filed together with a non-confidential version, will be placed

on the public file and be made available to other interested parties. If a

document is indicated to be confidential but a proper non-confidential

document complying with the above-mentioned rules is not filed, then the document will not be taken into consideration by the Commission. The public

file is available for inspection at the Commission's offices by all interested

parties, by appointment. Please take notice further that interested parties are

encouraged to inspect the public file regularly.
