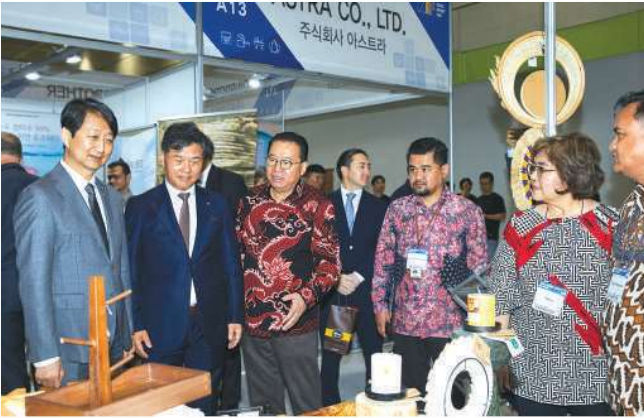



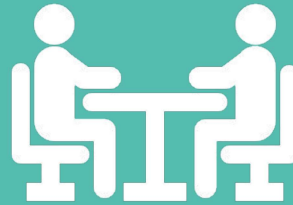

B2B MEETING

■ OVERVIEW

The annual **Korea Import Fair (KIF)** is a flagship project organized by the **Korea Importers Association (KOIMA)**, since **2004**. The event underwent a complete transformation from the previous “Import Goods Fair” to the “Korea Import Fair” in order to secure a stable supply chain of high-quality raw materials to expand international trade and strengthen Korea’s competitiveness in imports.

The Korea Import Fair 2023 (KIF 2023 henceforth), was successfully held for three days from **June 29th to July 1st, 2023**, at **COEX Halls C1 and C2** in Samseong-dong, Seoul. KIF 2023 marks the 20th anniversary of this annual event. **87 exhibitors**, including **41 embassies** from

47 countries, comprised of Korean importers, foreign exporters, the foreign Embassies in Korea and other partner organizations participated, occupying in **147 booths**.

As a trade organization that focuses on import, KOIMA has proudly organized **7 Seminars** on trade policy and business strategy, along with **128 B2B Meetings**. B2B has been the buzzword throughout KOIMA’s preparation of the KIF 2023. From the onset, KOIMA spared no effort in making sure this event rightfully serves the interest of businesses across the world. **The Korea Import Fair 2024** is scheduled to take place **from July 4th 2024 to July 6th 2024** at **COEX Hall B**, Seoul, Korea.

PERFORMANCE

① Opening Ceremony

The opening ceremony of the 20th Korea Import Expo was attended by a total of 77 people, including the head of the Ministry of Trade, Industry and Energy, foreign ambassadors to Korea from 47 countries, the Minister of Trade of Slovenia, heads of major economic organizations, and executives from the Korea Importers Association.

② Consolidating the status of the exhibition

This exhibition underwent a name change to become the “Korea Import Fair”, setting the stage for its transformation into a premier trade-related exhibition for the country. In alignment with this transition, a special exhibition focusing on semiconductor materials, parts, and equipment was curated.

This initiative aims to foster the advancement of the nation’s core industries while simultaneously elevating the stature of the Korea Import Expo.

③ Intermediating B2B Meetings

The Korea Importers Association conducted 128 B2B consultations between Korean and foreign companies in 29 countries, including Vietnam, Canada, and Lithuania, recording approximately KRW 2 billion in consultations.

④ Various Seminar Programs

Opportunities to provide information to attendees in various fields were given, such as major trade products and economic trends in Cambodia, introduction of Foshan in China, introduction of overseas remittance and payment solutions, and technology seminars related to the semiconductor fields.

GOALS

The Korea Import Fair has solidified its position as a representative domestic exhibition centered on the 4th industry. The annual Korea Import Fair aims to achieve mainly three things.

① Enhancement of status as a B2B import specialized exhibition

The B2B Meeting is KIF's largest event. To firmly establish its position as a specialized B2B import exhibition, several steps must be taken.

Firstly, enhance the promotion of B2B consultation results by actively encouraging pre-B2B matching and signing contracts/MOUs. Next, strive for tangible outcomes by effectively utilizing the association network.

Moreover, attract companies related to the 4th industry by diversifying business matching and collaborating with local governments. As a result, importers and buyers by country and item should be actively invited.



② Promote platform awareness to improve trade imbalance in trade origin countries

First of all, we will establish a more substantial and satisfactory exhibition operation process by actively reflecting the difficulties and feedbacks of participating companies in this exhibition.

In addition, we will continue to cooperate and encourage more countries and companies to participate by recognizing fairs as major exhibitions nationally and actively supporting them through various national networks established through import delegations.



③ Solidifying mutual relationships

The Korea Import Fair provides a number of opportunities for communicating with various participants. Through the KIF, reinforcing cooperation with domestic and foreign trade-related organizations can be made.

Also, KOIMA aims to strengthen business cooperation with foreign embassies, trade representatives and trade-related organizations in Korea.



IMPROVEMENTS

For next year's event, we will initiate booth applications in advance and ensure adherence to the deadline, along with preliminary booth recruitment and structured scheduling.

In addition, based on the results of this year's B2B conference, we will actively seek out guidance and matching companies so that more conferences between domestic importers and overseas exporters can be held next year.

Furthermore, we will expand online and offline pre-promotion for the diversity of exhibition items.

Lastly, we will strengthen publicity to expand participation by general visitors.

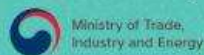

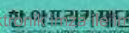
