DECISION

On 07 April 2020, No. 44, Moscow

On amendments to the common Commodity nomenclature of foreign economic activity of the Eurasian economic Union and the Common customs tariff of the Eurasian economic Union for certain types of components for the production of hand-held power tools, as well as to the Decision of the Board of the Eurasian economic Commission from April 19, 2016, no. 36 In accordance with articles 42 and 45 of The Treaty on the Eurasian economic Union of may 29, 2014 and article 2.4 of the free trade Agreement between the Eurasian economic Union and its member States, on the one hand, and the Socialist Republic of Vietnam, on the other hand, on may 29, 2015, the Board of the Eurasian economic Commission decided:

1. Make the following changes to the common Commodity nomenclature of foreign economic activity of the Eurasian economic Union and the Common customs tariff of the Eurasian economic Union (Annex to The decision of the Council of the Eurasian economic Commission of July 16, 2012 No. 54):

a) exclude items from the common Commodity nomenclature of foreign economic activity of the Eurasian economic Union in accordance with **Annex 1**;

b) include it in the unified Product nomenclature foreign economic activity of the Eurasian economic Union all items in accordance with **Annex 2**;

C) set the rates of import customs duties; customs tariff of the Eurasian economic Union according to **Annex 3**;

d) add notes to the Unified customs tariff Of the Eurasian economic Union note 74C of the following contents:

"74C) the rate of import customs duty in the amount of O (zero) % of the customs value is applied from the date of entry into force of The decision of the Board of the Eurasian economic Commission from April 7, 2020 No. 44 to 30.06.2022 inclusive.".

2. in the list of individual goods subject to import customs duty rates in accordance with the free trade Agreement between the Eurasian economic Union and its member States, on the one hand, and the Socialist Republic of Vietnam, on the other hand, dated may 29, 2015, and the amounts of such rates, approved By the decision of the Board of the Eurasian economic Commission dated April 19, 2016 No. 36:

replace the item with the code 8536 50 800 0 OF the customs code of the EEU with the following items: "8536 50 800 1 switches 12,3 10,9 9,5 8,2 6,8 5,5 4,1 2,7 1,4 0

For manual production power tools[^] 8536 50 800 9 other 12,3 10,9 9,5 8,2 6,8 5,5 4,1 2,7 1,4 0";

replace the item with the code 8545 20 LLC 0 OF the customs code of the EEU with the following items:

"8545 20 LLC 1-for production 12,3 10,9 9,5 8,2 6,8 5,5 4,1 2,7 1,4 0

Manual power tools 8545 20 LLC 9 - - other 12,3 10,9 9,5 8,2 6,8 5,5 4,1 2,7 1,4 0".

3. This Decision shall enter into force after 30 calendar days from the date of its official publication, but not earlier than the date of entry into force of the decision of the Council of the Eurasian economic Commission on amendments to certain decisions of the Council of the Eurasian Economic Commission in respect of certain types of components for the production of manual power tools.
